# 41/23 Matters arising from the minutes.

- (b) Y Graig junction Cllr S Phillips declared an interest. No response received from County Council. Request to be made for copies of Llanpumsaint Community Council minutes.
- (c) Safety barrier provision Clerk has spoken to Mrs Williams at Felinfach. Awaiting a reply from Carmarthenshire County Council. Item to remain on Agenda.
- (d) Garages in Cwmdwyfran awaiting response from Carmarthenshire County Council
- (e) Gwili Railway following a further email from Cllr R Carpenter on the 28.08.23 Mr Matt Bowen replied on the 30.08.23 stating that they agreed that the area in question does need tidying and expected the work to be carried out over the winter.
- (f) Subsidence near the church Nothing further to report.
- (g) Parking issues Bronwydd Road Cllr B Davies has sent an e-mail to Mr Peter Hughes-Griffiths and Carmarthen Town Council regarding the concerns raised. No further information at present.
- (h) Sheep Dip Cllr G Evans has spoken to Mr W Evans and Mr R Evans, Trefynys who agreed that the work can be carried out. Agreed that Cllr Evans obtains 3 quotations for the work of clearing the area concerned, re-welding the metalwork and removing any rubbish. It was requested that photographs be taken of the area. Further discussion to be undertaken regarding the possibility of placing a plaque near the sheep dip.
- (i) Funding requests clerk to contact the Bowls Club for documentation regarding the grant given. Agreed to convene a subcommittee meeting before the next full meeting to discuss the funding policy. Cllr D Jones and Cllr A Conti agreed to be members of the subcommittee.
- (j) 20mph speed limit Cllr A Conti declared an interest. Noted the following points:-
  - Pentremorgan is suffering due to the change in speed limit
  - 400,000 have signed a petition against the new speed limit
  - A484 is an A road ambulance with sirens and blue lights unable to pass because of a queue of vehicles doing 13mph.
  - Significant increase in traffic from 6.00a.m.
  - Cars overtaking on the straight piece of road
  - Pavement in Pentremorgan with 20mph, walking towards Cwmdwyfran pedestrians have to cross the road with 30mph before returning to 20mph
  - Cost of new road signs

A lengthy discussion followed and it was agreed that there wasn't enough data at present and drivers require time to adjust. Agreed to leave the item on the agenda for further discussion.

Planning Department confirmed that all was in order with the alterations at the Old Smithy in Cwmdwyfran.

Conversion of garage to ancillary accommodation in part of the rear garden of the shared dwelling at Greenacres, Bronwydd Arms. No objections raised.

Raise roof of existing building to gain additional headroom in the loft area to create bedroom area at Fron Fras, Bronwydd. No objections raised.
